General Policies and Procedures

Camp Hours

Camp hours are from 9:00am to 4:00pm. Extra Early drop off is available from 7:00 to 9:00am, Early drop off is available 8am-9am and Late pick-up from 4:00-5:30 for an additional fee.

Financial Policies

Payments can be made in full at our online store or you can make a \$25.00 <u>non-refundable</u> deposit per week to "hold" a spot for your child, with full balance due on Monday of camp week (cash, check or credit card payment accepted). Payment is expected for all days registered whether attended or not. No credit or refunds are given for absences except due to serious illness document by a physician. Camp reservations must be made by 4pm the Wednesday prior to the week that your child will be attending. Any reservation made after the cut off will result in a \$25.00 fee.

There will be a late fee if your child is picked up after 5:30pm. This fee must be made at the time of late pick up on the day applicable. Please do not make our staff ask for payment.

DROP INS

Daily Rates for "drop ins" are \$50.00 per daily or \$8.50 PER HOUR and must be scheduled 24 hours in advance. Full payment must be paid daily. If 24 notice is not given, there will be an additional fee of \$10.00. All paperwork will be due at time of sign up (24 hours in advance).

Personal Property

Cell phones, iPods and any other electronic equipment are not allowed during summer camp. Any kind of trading cards or Pokémon cards are not allowed. If you feel that your child must have a cell phone, it will be kept locked in the main office, available to be used in case of emergency only. All personal property must be label with child's name.

Maple Ski Ridge and its staff is not responsible for damaged, lost or stolen items. Please call the main number if you need to speak with your child or a staff member. 518-381-4700

Clothing

Children should wear weather appropriate clothing and sneakers daily. Bring a bathing suit (or wear one) and towel to camp daily, as water activities will be available on most days. Children should come to camp daily ready to play and get dirty. Do not send children to camp in "good" clothes. Paint and glue will also be available for art projects. Please bring a change of clothes and shoes daily.

Sun Protection

Apply sun protection on your child prior to coming to camp. We ask that you also pack extra to re-apply during the day. Spray cans are best. Please label with your child's name.

Coming and Going

At no time should your child be dropped off at the front door. You must sign your child in at the main desk and record who will be picking up your child and time they will be picked up.

Sign out will also be at main desk. Please have ID when picking up your child. If someone other than yourself will be picking up your child, you must inform us. Only people who are authorized on their registration packet will be allowed to pick up your child.

Tax Forms

If you will need a tax statement for your summer camp expenses, this request must be made no later than September 1st. All tax statements will be distributed by November 1st. Any tax form requests after September 1st will not be completed until after April 1st.

Food

Your child must either bring a bag lunch, snacks and beverages or purchase lunch and snacks from us. Refrigeration is available upon request. If your child has any food allergies, please make sure we are aware. We will have a peanut free table available during lunch. Please send a large water bottle for your child. Label all bags and bottles.

Discipline Policy and Camper Expectations

The Camp Director and Owners reserve the right to suspend or expel a camper at any time due to misbehavior. A Zero Tolerance Policy is in effect for any camper who demonstrates conduct that could cause themselves, another camper or staff member physical harm. Vulgar language and physical altercations will not be tolerated. Disrespect toward another camper or staff member will not be allowed. The Camp Director or Assistant Camp Director will call and personally speak to a parent when their child demonstrates misconduct. All disciplinary actions will be documented by staff. Please review the attached form and sign.

Camp Maple Summer Camp Discipline Policy

The Day Camp staff at Maple Ski Ridge would like your child to have the best experience possible while at camp this summer. Thus, all participants must understand and follow the camp guidelines and expectations. These guidelines and expectations are in place to ensure the safety of your child, other campers and our staff.

Camp Maple Camper Expectations

- 1. Listen to staff

- 5. Resolve disagreements in a positive manner
- 6. Use appropriate language at all times

- Step 4: Camp Director or Assistant Director will phone parent to speak about their behavior.
- Step 5: Meeting with the Camp Director, Owner, necessary staff, parent(s)/guardian, and camper. At this time, suspension or expulsion will be discussed.

Camp Maple Outside and Unplugged

Camp Maple COVID-19 Considerations

On June 2nd, Governor Cuomo announced that Day Camps would be operating this summer, which was the news everyone here at Camp Maple was waiting for! With that announcement, New York State issued guidance on June 8th for how we can ensure that we do so safely for our campers and staff. Working with that guidance, we have put the following practices in place for this summer at Camp Maple.

Social Distancing

- Campers will be in groups of 10 or fewer this summer.
- Any requests for your child to be with another camper need to be submitted at least 2 weeks prior to the session.
- Practices will be in place to limit parents and caregivers entering the lodge, to comply with NYS guidelines.

Face Coverings

- Camp Maple Staff will be wearing face coverings at all time.
- Campers will be required to wear a face covering upon arrival to camp in the morning, and any time they are inside a camp building.
- If camper refuses to wear face covering after reminder from staff, parents will be called to pick camper up for the day.
- During outside play within their 10-camper group, campers will be able to take their face covering off.
- Parents and caregivers will be required to wear a face covering during drop off and pick up when out of their vehicle or interacting with Camp Maple Staff.

Health Screening

Every morning, each camper and staff member will undergo a COVID screening process, to ensure each member of our camp family is healthy and safe. This screening will include:

- Temperature check
- Screening questions to determine if COVID symptoms are present
- Recent COVID testing status
- Recent contact with individuals with known or suspected COVID illness

If your camper is ill in the morning before coming to camp, we ask that you try to find alternative care plans for them that day. Our Health Director will have a low threshold for requiring children to be picked up from camp due to illness this summer because of the wide range of presenting symptoms of COVID related illness.

Drop Off

- On arrival, vehicles will be directed to the left of the parking lot, to drive in a circle ending at a station where they will meet the Camp Director.
- Parents will complete any outstanding paperwork and payments with the Camp Director. Parents and campers are asked to remain in their vehicle and have face coverings in place during this process.
- After completing payments and paperwork, Parents will then pull forward to meet with the Health Director. Health Director will ask screening questions and check Camper's temperature.
- Camper will proceed into lodge, wash their hands, and meet with their group and counselor after clear health screening.

Daily Activities

- Campers will wash their hands when they enter the lodge in the morning for camp, with face coverings in place.
- Whenever campers enter the lodge, they will wash their hands and have their face covering on.
- At lunch time, campers will wash their hands as they enter the lodge. They will then gather their lunch and
 everything they need for the meal and join their group and counselor at their designated table. Once seated,
 campers can remove their face covering for the meal.
 - o If a camper needs to retrieve another item for their meal, they will be required to put their face covering back on to leave the table and retrieve it.
- After lunch, campers will wash their hands before returning to activities.

Pick Up

- Parents will drive through loop in parking lot, ending at lodge door.
- On arrival, phone number will be posted to call and inform staff of arrival.
- After confirming identity, Camper will be sent out to meet parent.

Please review these procedures with your camper. Our goal is to make sure our campers and staff have a safe	, healthy,
